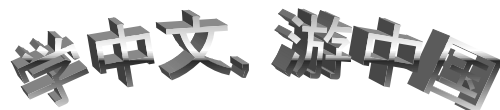

AGREEMENT AND RELEASE

1. I, the undersigned, an applicant for a program of Sino Language Gateway (hereinafter referred to as SLG), a California registered corporation, acknowledge that the terms and conditions appearing in the program brochure or itinerary description constitute part of my agreement with SLG, including sections concerning responsibility, refunds, possible changes in itinerary, accommodations and courses.
2. I understand that the program fees and information are correct at the time of publication, but are subject to change due to currency fluctuations and other unforeseen circumstances. If such change occurs, I (or my financial guarantor) agree to make the supplementary payment to SLG once we are informed.
3. **Compliance with Rules and Regulations**
I will comply with SLG and host institution rules and regulations while I am a participant of SLG's program during the program period; I agree to observe and obey Chinese laws and regulations, and accept Chinese social morality and customs.
4. **Waiver**
 - a) I agree to waive and release all claims against SLG, its affiliated organizations, its administrators, directors, agents, independent contractors and other employees and volunteers of the organization, other participants, sponsoring agencies, sponsors, advertisers, under any theory of law or equity for any injury, loss, damage, accident, delay or expense resulting from events beyond its control, including (without limitation) acts of God, war, act of terrorism, strikes, riots, incidents of politically-motivated violence, sickness or quarantine, government restrictions or regulation or, in the absence of its own negligence, arising from the use of any vehicle or from the selection or any act or mission of any host family, steamship, airline, railroad, bus company, taxi service, hotel, restaurant, school, university or other firm, agency, company or individual.
 - b) It is my understanding that participation the activities that make up SLG program is not without some inherent risk of injury. As such, in consideration of my participation in SLG program, I hereby release, waive, discharge, and covenant not to sue the program, servants, agents, or employees from any and all liability, claims, demands, action, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, whether caused by the negligence of the releases, or otherwise while participating in such activity, or while in, or upon the premises where the activity is being conducted.
 - c) I understand that I am responsible for taking all measures and exercising caution and common sense at all times to avoid injuries. I understand SLG is providing as part of my program fees limited travel accident and sickness insurance coverage for my benefit, in event of injury or illness while on a SLG-sponsored program. I further understand that SLG is not responsible for any injury or loss arising at a time when I am not under the direct supervision of SLG and its affiliated organizations, such as independent travel, or during any absence from the host school or other SLG-supervised activities. I expressly acknowledge and agree as a condition of traveling on a SLG program that I (and anyone claiming through me) shall have no rights whatsoever, directly or indirectly, under any theory at law or in equity against SLG except (i) for refunds in the circumstances described here, and (ii) to the same extent (including deductibles, exclusions and maximum limits) that such claims are covered and amounts are actually paid under insurance policies included by SLG for my benefit with the SLG program. I understand SLG has obtained this insurance to provide alternate coverage for me instead of, and in place of, any rights or claims I may otherwise have against SLG or related persons.
 - d) I hereby grant SLG and its affiliated organizations full authority to take whatever actions they may consider to be warranted due to any international or political unrest, personal emergency or other event regarding my health and safety, and I fully release each of them from any liability for such decisions or actions as may be taken in connection therewith.
5. **Standards of Conduct**
I agree that SLG, its affiliated organizations, and the host institute shall have the right to enforce appropriate standards of conduct and that it may at any time terminate my participation in its program for failure to maintain these standards or for any actions or conduct which SLG, its affiliated organizations, and the host institute consider to be incompatible with the interest, harmony, comfort and welfare of other students, staff, or the laws of the People's Republic of China. I hereby waive and release all claims against SLG, its affiliated organizations, and the host institute arising out of my failure to remain under such supervision or to comply with such rules, standards and instructions, and any consequences thereof. I will also accept in good faith the instructions and suggestions of SLG and its affiliated organizations in all matters relating to SLG's program or the personal conduct of program participants.
6. **Termination of Participation**
I agree that I shall have no right to any refund of any part of my program fee upon termination of my participation from the program and that upon notice by SLG or its affiliated organizations, whether verbally or in writing, I shall forthwith depart from the program and to return home at my own (or my financial guarantor's) expense. I also understand that, if I leave the program voluntarily for any reason, there will be no refund of fees already paid.

7. Refunds

I understand and accept that refunds will be following the table below excluding the program deposit of US\$300 and airfare deposit \$200 (if paid):

The refund policy is as such due to the many expenses involved in arranging a program and the various policies of schools and housing. Please note that SLG makes financial commitments on behalf of its participants well in advance of the start date.

a) In the event that I fail to present myself for the entire or any part of the program, no refund of any fees already paid to SLG shall be made, unless I have given prior written notice to SLG stating full reasons, and has obtained prior written approval from SLG. To avoid doubt, SLG has the sole discretion, and is not bound to, grant any approval. Further, any periods of absence may not be made up with free extension of the program, unless with the prior consent in writing from SLG.

b) Once the program has commenced there shall be no refund of program fees. In case of emergency, or for medical reasons, as outlined in the insurance policy, claims should be directed to the insurance provider you are signed up with, if any.

c) In the event that the program I have registered and enrolled in, for whatever reason cannot start on the original intended date, I agree to either accept a refund of program fees (minus the application fee) or to start the program on the next available program closest in date to the original program or defer my program start date until a time which is mutually convenient for me and SLG (and in any event, within one year of the original application date) and where there is a program scheduled to begin.

d) Any bank or transfer fees associated with the refund of the program fees shall be the responsibility of the refund recipient.

8. Cancellation and Changes

a) I understand that SLG and its affiliated organizations reserve the right to make cancellations, changes or substitutions in cases of emergency or changed conditions or in the interest of my group. On group tours or other activities arranged by the program I will accept the will of the majority whenever a matter of choice is presented to the group.

b) I understand and accept that SLG, its affiliated organizations and the host institute reserve the right to cancel programs due to insufficient number of registered participants and to reschedule my program start date to another time. SLG and its affiliated organizations also have the right to cancel any course due to insufficient registration, or place students at other university/academy/school programs or defer the program until another date when there are less than 10 students in a class.

c) I understand and accept that SLG, its affiliated organizations and the host institute reserve the right to cancel programs in the event of severe infectious disease. SLG's cancellation decision will be based on the WHO announcement regarding to the disease affected areas on its official website <http://www.who.int>.

d) I agree that I may not cancel a service type once the program has started. Any downgrade or upgrade service type must be notified to SLG and its affiliated organizations at least 30 days in advance to allow SLG adequate time to arrange the service for me. I understand the service type needs to be offered by SLG and its affiliated organizations and I will pay the fee differential immediately.

9. Currency fluctuation surcharges

Prices are based on foreign exchange rates current as of program pricing and are subject to surcharge if and as exchange rates fluctuate. However, any such surcharges will be limited to not more than \$100 per person per session.

10. Trip Modification

The program price allows parents/students to make one free trip modification, such as changing arrival/departure date, requesting/removing extra accommodation or Specialty Optional Courses, adding/deleting accompanying parent/sibling, etc. Any subsequent change will be charged \$30. All change requests must be made in written format (email/fax/mail).

11. Medical, Health, Insurance

a) I understand that all foreign students studying in China must purchase medical insurance; and that if I instruct SLG to not purchase insurance on my behalf, I must purchase insurance on my own.

b) I understand that as part of my program fee, SLG will purchase limited international travel accident and health insurance for my benefit prior to my departure. I have the option to purchase additional travel accident and health insurance coverage if I deem necessary with additional fees, and it is my responsibility to understand the content, coverage and applicability of such insurance policy.

c) I understand that the insurance policy is between the insurance provider (Specialty International) and myself, and that SLG is not a party to the contract.

d) I accept that any insurance claims to be made to the insurance provider (Specialty International) will be done directly to the insurance provider without the involvement of SLG.

e) I authorize SLG and its affiliated organizations at their discretion and without my further consent for any emergency medical care or treatment by a physician, surgeon, hospital or medical care facility that may be required, including transportation, and accept responsibility for the cost. Or if no hospital is readily available, to place me in the hands of a local medical doctor for treatment. If deemed necessary or desirable by SLG or its affiliated organizations, I authorize them to transport me back to my home country by commercial airline or otherwise at my own (or my financial guarantor's) expense for medical treatment.

12. Use of Photos and Statements

I understand that from time to time SLG's publicity material may include statements by its students/parents and/or their photographs, and I consent to such use of my comments, photographic, video tapes, and voice records likeness. I further agree to the release of my name and address to other participants of my group unless I expressly notify SLG not to do so in writing.

13. Visas and Travel Documents

I understand and accept that it is my responsibility to obtain the Chinese visa and/or other required travel documents and in the event I cannot obtain the visa for participation I shall not hold SLG responsible. Failure to secure the necessary visa does not constitute grounds for a refund except that my visa application is rejected by the Chinese Authorities, I will be entitled to 100% refund of the program fees (excluding the application and airfare deposit), provided that: a) I give SLG written notice and show the visa rejection letter given by the Chinese Authorities; b) the program I have enrolled has not already started, and c) that I have not already started the program for which I have enrolled.

14. Loans

In the event SLG or its affiliated organizations advance or loan any monies to me or incur special expense on my behalf while I am abroad, I (and my financial guarantor) agree to make immediate repayment prior or upon my return.

15. Modifications

All references in the Terms & Conditions to "SLG" and its "affiliated organizations" shall include SLG and all of its officers, directors, staff members, campus directors, chaperones, group leaders, teachers, host school or school officials, employees, agents and affiliated companies. This agreement will be effective when my application is accepted by SLG. I understand that my agreement with SLG cannot be modified or interpreted except in writing and that no oral modification or interpretation shall have any validity.

16. Legal Governance

If any part of this Terms & Conditions is determined to be invalid by law, all other parts shall remain valid and enforceable. This Terms & Conditions shall be governed by the laws of the State of California, and/or the People's Republic of China applicable thereto (at the choice of SLG).

Code of Student Conduct

Students who intent to participate in SLG programs must sign in order to be enrolled in the program.

1. Students must attend every class and complete homework on time.
2. Students are expected to respect teachers; follow instructions of the authority; take care of your study materials; keep classroom clean after using it; and take responsibility of one's own behavior.
3. Respect your peers and other people, do not harass, threaten, intimidate, harm or insult anyone.
4. No fights or violent acts or illegal activities under both China and U.S. law.
5. Keep the school property and others' personal property safe and free from harm.
6. Use polite language and gestures.
7. Be honest, do not lie or steal.
8. Individual students are NOT allowed to leave the campus.
9. With camp director or counselor's approval, students older than 14 years old AND in a group of 3 or more may go out of campus and stay out until 9:00pm. Always ask for permission before leaving the campus and follow the approved route. You need to notify the camp director immediately if a change of plans becomes necessary.
10. Parents/visitors should ALWAYS SIGN the leave-for-absent sheet before taking students out of campus.
11. No smoking, drinking alcohol, or use of illegal drugs is allowed.
12. Students shall sleep in their assigned rooms and beds.
13. At 10:00 pm students MUST be in their rooms and must not be disruptive to other students.
14. No room visits between boys and girls should occur after 9:00pm. Boys and girls are prohibited from having close physical contact during the camp. Sexual behaviors are absolutely prohibited.
15. Students cannot gather in the dorm rooms. A social room on the same floor as the dorms is provided for gathering.
16. Students cannot use candles or any other flammable devices in the dormitories.
17. No pets allowed in the camp.
18. Meals will be provided for students in the buffet style. Students are advised only to take the food they are capable to consume. Waste of food is not allowed.
19. Meal cards are only supposed to be used for purchasing meals, food, snacks and drinks. If it is found that it being used for purchasing apparel, entertainment goods, or any other products, your meal card will be confiscated.
20. Insignificant violation will be warned orally. Serious violation will be notified to your parents immediately, and may result in dismissal from the camp.

Consequences:

In the event of a dismissal, SLG will make arrangements for the dismissed student's return flight back to home country and will accompany the student to the airport. However, we will not provide anyone to escort the dismissed student on the flight and parents are expected to make arrangements for all subsequent travels in the U.S. No portion of tuition or fees will be refunded to a dismissed student. Parents or guardians are responsible for any additional expense occurred as a result of his/her dismissal.

SLG reserves the right at any time to decline to accept or retain and to disqualify from the Program or any portion of the Program any person whose conduct impedes the Program's normal operation or the rights, welfare or enjoyment of other participants. Refunds of tuition or fees will not be given under such circumstances.

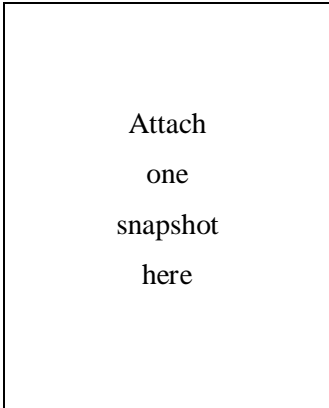
